- > DUE TO HEAVY TRAFFIC AND LIMITED NUMBER OF PARKING STANDS, AIRCRAFT GROUND TIME SHALL NOT BE LONGER THAN 12 HOURS FOR THE CARRIERS (SCHEDULED AND NON-SCHEDULED) OPERATING AT BKK.
- > AD HOC, CHARTER, ADDITIONAL FLIGHT REQUESTED GROUND TIME MORE THAN 4 HOURS CAN BE CONSIDERED UPON AVAILABILITY OF PARKING STAND.
- > PRIVATE OPERATION CANNOT BE ACCOMMODATED.
- > PARKING STAND MINIMUM BREAK TIME BETWEEN ARRIVING AND DEPARTING AIRCRAFT IS 30 MINUTES. (15 MINUTES FOR DELAY DEPARTURE AND 15 MINUTES FOR EARLY ARRIVAL)

- > THERE ARE 286 CHECK-IN COUNTERS IN SERVICES, CALCULATED BY 70 PASSENGES PER COUNTER, ANY EXCESS WILL ROUND DOWN NUBMBER OF CHECK-IN COUNTER.
- > CHECK-IN COUNTER WILL BE IN SERVICES 3 HOURS BEFORE STD, AND CLOSE 40 MINUTES BEFORE STD.
