



Notification Of the Civil Aviation Authority of Thailand

Re: Controlling or Launching a Pilotless Aircraft, Type: Pilotless Aircraft of the Externally Piloted Aircraft in the areas along the route that the Holy Tooth Relic of Lord Buddha will be taken
B.E. 2568 (2025)

Thailand has invited the Holy Tooth Relic of Lord Buddha from Lingguang Temple in Beijing, People's Republic of China to be temporarily placed at Sanam Luang in Bangkok, for general public to worship, between 5 December 2024 until 14 February 2025. Pursuant to Article 17 of Announcement of the Ministry of Transport, Re: Rules to Apply for Permission and Conditions to Control and Launch Unmanned Aircraft in the Category of Remotely Piloted Aircraft B.E. 2558 (2015), Article 19 of Notification of the Ministry of Transport on Criteria for the Permission and Conditions for the Operation or Release of Pilotless Aircraft of the Externally Piloted Aircraft Type with a Weight Exceeding 25 Kilograms B.E. 2567 (2024) and Notification of the Civil Aviation Authority of Thailand on Criteria for the Permission and Conditions for the Operation or Release of Pilotless Aircraft of the Externally Piloted Aircraft in the Restricted Area VT R1 Bangkok City B.E. 2566 (2023) The Director General of the Civil Aviation Authority of Thailand may grant a permission for the operation or release of pilotless aircraft of the externally piloted aircraft within the Restricted Area VT R1 Bangkok City under specified conditions. However, The Director General of the Civil Aviation Authority of Thailand may also revoke such permission within specify date and time, if necessary.

For the purpose of safety and preservation of peace and public order in the areas along the route that the Holy Tooth Relic of Lord Buddha will be taken back to People's Republic of China, and to comply with the Royal Thai Police's security plan, by virtue of Article 5 of Notification of the Civil Aviation Authority of Thailand on Criteria for the Permission and Conditions for the Operation or Release of Pilotless Aircraft of the Externally Piloted Aircraft in the Restricted Area VT R1 Bangkok City B.E. 2566 (2023) The Director General of the Civil Aviation Authority of Thailand shall revoke a permission for the operation or release of any pilotless aircraft of the externally piloted aircraft on 15th February 2025 from 05.00 am. until 10.00 am. local time, within a radius of 10 nautical miles (approximately 19 kilometers) from the Victory Monument, Bangkok and at the height from 0 up to 3,000 feet above ground level (AGL). The operation or release of any pilotless aircraft of the externally

piloted aircraft within the Restricted Area VT R1 Bangkok City within that specified date time and location is strictly prohibited. Any person who is in violation of the aforesaid provisions shall be liable to imprisonment for a term not exceeding one year or a fine not exceeding forty thousand baht or both, according to Section 78 (1) of the Air Navigation Act B.E. 2497 (1954).
